

## CU Inworks Terms of Use

Inworks operates and maintains prototyping facilities that offer a wide variety of tools and equipment allowing individuals to design and fabricate working prototypes of project designs. Many of these tools and equipment are potentially dangerous to you or to others if operated in an unsafe manner. In addition, the operation of Inworks prototyping equipment has inherent potential risks. If these machines are used in an unsafe manner you could be subject to serious injury including loss of limb and death. Safe use of our facilities requires strict adherence to principles of general workshop safety and to the specific safety requirements for each machine or tool. Because some Inworks equipment can be dangerous we have developed a set of terms that govern and control the use of Inworks prototyping facilities. This is not a contract between you as a participant and Inworks. Your agreement to these terms does not guarantee access or time in Inworks prototyping facilities. Instead, these are the minimum terms of use for you to be considered for access to Inworks.

### **I understand and agree that my access to Inworks is conditioned upon the following:**

1. As a participant in Inworks, I understand and agree that my participation and access to Inworks is completely voluntary. I understand that I am being permitted to have access to the prototyping facilities and that this access may be suspended or revoked by the Inworks Director if I fail to meet these terms of use, or if at any time the Director evaluates my use of the prototyping facilities as unsafe.
2. As a participant in Inworks, I understand and agree that I will follow all rules and policies involving use of equipment and the facilities. I agree to strictly comply with “Inworks General Safety Rules,” all posted machine-specific safety rules, and any other safety expectations and guidelines conveyed to me by Inworks staff or faculty. I will not use or touch any equipment or machinery until I have been properly trained and evaluated on its use. I agree that if at any time I am unable to safely utilize the equipment or machinery because of a temporary or permanent incapacity, I will notify the Inworks Director.
3. As a participant in Inworks, I understand and agree that the primary function of Inworks facilities is to support the educational mission of the University of Colorado Denver | Anschutz Medical Campus. I understand that Inworks facilities are not to be used for any commercial manufacturing purpose.
4. As a participant in Inworks, I understand and agree that my access to Inworks facilities is non-exclusive, and I agree to abide by the access and usage priorities established by the Inworks Director. I understand that academic and class-related usage have the highest priority.
5. I understand and agree that the Inworks Director may require me to undergo a criminal background check prior to authorizing my access to Inworks facilities.
6. As a participant in Inworks, I understand and agree that I will use my best efforts to preserve and protect Inworks equipment and facilities. I understand and agree, that if I damage or destroy any equipment or facilities as a result of my negligence or carelessness, I will be responsible for the repair or replacement of the equipment and facilities.

7. As a participant in Inworks, I understand and agree that I will be expected to act professionally and appropriately at all times. I understand that if I fail to do so, the Inworks Director may immediately terminate my access and I may be reported to the Office of Student Conduct and Community Standards or the Dean of my school or college.
8. As a participant in Inworks, I understand that I will be working around and utilizing equipment that can be dangerous. This means that I am voluntarily choosing to expose myself to these risks including, but not limited to: rotating machinery, moving tools and blades, flying objects, hot objects, sharp objects, eye hazards and tripping hazards.
9. As a participant in Inworks, I understand that I will not be covered by the University's liability insurance nor Worker's Compensation insurance when working in Inworks. I understand that it is recommended that I obtain or purchase my own health insurance coverage.
10. As a participant in Inworks, I understand that Inworks utilizes access controls to the prototyping facilities. I understand and agree that I will not share my access credentials with anyone. I understand that if I share either intentionally or through negligence my access credentials, I am subject to immediate termination of access to the prototyping facilities and I will be responsible for any damage/destruction/loss that occurs as a result of my sharing my access credentials.
11. I understand and agree that if I am a non-student participant in Inworks, I may be required to pay a registration, license or subscription fee to have access to Inworks. I understand and agree as anon-student that my access may be limited due to academic priorities, that my access is revocable, and that I can be refused access if I fail to comply with these conditions. No refund or other remedy will be provided if I am refused access or if my access is limited because of academic priorities.
